Big Governance State

The interplay of all developments from the time of World War I has brought to this era of afflictions and lawlessness. In prior, birth of Protestantism and pursuant Industrial Revolution had marked the start of social and economic decay. Now in this times of near complete interconnection, or precisely, collusion, between banking, industry and governance, theoretical divisions in any of them, or among them, only remain on paper. Everything in essence dilutes into the accumulation of profit, wealth and authority, to a larger part, at the cost of sustained human development. During the course, pristine nature, harmonious society, and inclusive economy are all wiped out. Thus all such entities and institutions, often with forcefully claimed dominion, relevance, purpose, and objectives, both stated and unwritten, are there only to facilitate such a pursuit of money, power and pleasure, that too only to a coterie of so-called elites and their stooges. This is done in an unrelenting manner under a legalised banner.

The convergent pool of powers at its disposal, accumulated both legally and deceitfully, such as muscle power, firepower, information power, technology power, and money power, are all unleashed by this beast system of governance against unscrupulous people, both good and bad, only to impoverish and enslave them. Those crafty and uncanny enough among the people prefer to remain corporate coolies, governmental slaves, and institutional farmhands, and to adore the beast. As the end result, there happened for everyone to behold the decimation of traditional and nature based industries and vocations, unwarranted and inordinate migration of skilled farmers and workers towards metropolitan areas, unrelenting pressure of vilest proportions upon land, water, air and resources, and finally, the irreversible decay of society with emasculated men, offended women, scandalised children, and forsaken elders.

To put this in perspective, social and economic conditions that have shaped the post-Wars era need to be rightly understood. The pyramidal serpent-beast-subjects big governance State model, that resembles both the Babylonian empire and, to some extent, the good old Roman empire, began to reemerge in the form of United Nations. At the zenith of absurdity, government is now an elite employer. Its extravaganza and lavishness knows no bounds. Its doling out of about four or five times higher an amount as salary and benefits to its subjects in contrast to self-financing or private institutions for a job demanding the same educational qualification, work specification, and skill level is but one simple example. To be an elite employer, the employer should be elite. Its earnings should far surpass its expenditure. For example, if a Company has technology that no one else can match, which it enhances year by year, and if the Company is able to sell out all of its production out of that technology even for a premium, then it is surely an elite employer. In that sense, elite salary is justified. In the case of government, nothing like this exists. It only collects money from people under the rationale of governance. Afterwards, it unforgivably expands the scope of revenue collection under many colourful terms like tax, duty, excise, toll, cess, and the like, only to put almost everything into its insatiable mouth.

Misinformation and Disinformation

This is the times knowledge has increased manifold. Information is burst out of bounds. Unlike the previous era, now almost everyone is a writer and publisher alike, thanks to technological advancements. What uncanny deceptions ascribed once to corporate media, could be found in such alternative media too. In that sense, paid news, blatant bias, suppression of truth, withholding critical information, highlighting superficial happenings, mixing facts with falsehood, deceptive titling, misleading arguments, confusing wordings, diversionary tactics, and wilful extolment or degradation of individuals, establishments, communities and societies are the realities of today. Information from every source attempts to shape individual, group, or social behavior of people, and seeks dividing them on different lines or uniting them on equal lines cutting across caste, creed, colour, age and sex. Thus information has undergone a gradual transition from being merely the dissemination of truth and gossip to a mind control mechanism, thereby having consequential bearing on the society's condition and conduct.

Therefore there is no greater cursed power in the world today than that wielded by the manipulators of public opinion. Their news and information do not merely paint black and white, that is, take a clear stand in favour of or against any person, social group, or ideology. With carefully developed psychological techniques it enables the reader/receiver to cultivate in and for himself or herself a perception towards a target person, group, community, or ideology by associating a sum of attributes that define the total personality of that target. Hence in today's news, there remains as much likelihood for an information to be false as it is to be true. Carried away by such sensation or polarisation of any kind, most men and women have fallen

away for deceptive misinformation, pursuantly drenched with preconceived notions, preformed opinions, and post-reading influences. Unbiased and valiant dissemination of truth at one end of the spectrum builds concordant society and economy, but misinformation and disinformation intended with abhorrent prejudice and subversion at the other end makes everything desolate as much as war and famine.

In this regard, the flow and control of information should be understood in proper perspective by the receiver. He or she should not get swayed away by sensational and trivial news. Nor should he or she allow himself or herself to get corrupted by the misinformation or disinformation in order that he or she wisely refuses to be a puppet absorbing the attitudes and values sown by the proponent(s), mostly ruling elites and their cohorts, as if drinking water. The receiver's ability to read between lines, as to why such headings and wordings are put, why a news item gets highlighted but another played down, why a news is presented under a false or twisted equivalence, why different yardsticks are wilfully applied for same situations or same yardstick for different situations, why deliberately apples are compared with oranges to force into treating unequals as equals, why one-to-one correspondence is not effected, why good and bad are intentionally mixed, and finally why perversions are offered as standard norms of the society, determines the slot in which the receiver stands in relation to moral and ethical edicts. This collectively determines the social direction in turn.

Global Corporatism

Lately people have recognised that most of corporate products are pernicious, let alone useless, and in the event of their being useful and indispensable, come with attached stings like much inflated cost, dependence for usage and maintenance, and even forced addiction or enslavement. Technology or expertise if any a corporate acquire is either by force or manipulative measures mostly swallowed up from smaller firms or individual researchers in the form of takeover, acquisition, merger, or anything else. An evil State is the benefactor and protector of corporate rapacity, which patronises them with moral and financial support with its muscle and fire power. If the nation-state is symbolised as a female hog, corporates are one of its rapacious sucklings.

Corporate relevance upon economy is rather minimal as in every nation, predominant of wealth is generated by diligent men and women under community vocational systems, which are both unaccounted and unrecognised. Evils the corporates commit upon humankind far outweigh the rationale for their existence, from consuming resources that are otherwise meant for local communities and vocations to polluting society and environment by pernicious drugs, chemicals, weapons and electronic waste. When a product has seven years lifetime, they see that it is

discarded after three years only to sell more of them. Even more, they wilfully tamper with the architecture so that it fails after a certain period or usage pattern. They have completely taken out the frugality virtue out of a whole generation. Their talk of optimality and effectiveness is only for them to eat up public labour and resources and make more money out of thin air.

A typical Indian corporate neither has technology nor has responsibility. It, under State support, meanders in gullible countries around the world to amass technology components of third or fourth rated quality for throwaway prices. They assemble them at their industry line, albeit with knowhow from the same gullible component and technology providers. Then they multiply the already-inflated cost with some unimaginably higher multiplier arising in their caprice of mind, and fix it as price. When there is no one to take their products, there is already a standby called government. It takes their manufacture in bulk in yet another level of inflated price, and as the consummate malevolence, with an unimaginable tag of service maintenance contract for a prolonged period. At the other end of the spectrum, corporates of very advanced technology and expertise, mostly western corporates, are there solely to channelise their knowhow towards military and bank innovations, rather than for greater common good, with the ultimate aim of enslaving people, wherein such innovations are impossible for individual persons or groups to both emulate and encounter.

Every one of collusion, propaganda and hypocrisy will ask for evidence. The prevalent social and economic conditions stand for themselves as living witness of this desolation of cosmic proportions. When petroleum products are priced this much even after the more than 200 percent decline of their international prices, augmented by supply glut, and when all other countries give them for almost half the price of what is given in India, how many other proofs are needed? When the same product of same specification is sold at least at one-tenth of the price in China, what else needs to be proved?

Aberrations of Masses

Nevertheless, the beast system of governance, along with its heads and horns, has overbearing power and authority only due to the aberrations of the rebellious masses. It is naive to believe that a handful of ruling elites control the entire world without the latter's will. There is a Tamil saying, 'Good or bad, comes not from others'. When every workman and woman, starting from the president down until the clerk comes from amongst the people to do every filthy task, how could blame be ascribed on a handful of others? When open sexual promiscuity is not answered with family and social opposition under the guise of individual liberty, and when rapacity of corporates is not met with mass agitations and resistance under the guise of development, then it is the fertile land where the big governance State grows.

Thus people refuse to realise that government is not a panacea. On the contrary, government has become the greatest social evil of this times. It is no close a substitute for self-governance by vigilant and diligent communities If many have the mindset to be part of that system, who else be blamed? A vast section of people are characterised by their inclination for plum positions in the very same government or corporates, their crave for bulk, easy, quick money, their running after lucrative intermediary occupational lines in contrast to productive ventures, their bank default pattern, their imperious neglect of others, their inordinate concentration in fraudulent businesses, and so many. Yet calling a spade a spade offends many.

Therefore it is for the people to decide whether to surrender the God provided sovereign independence for the sake of gratifications of the flesh. Moreover, envisaging maximum worldly goodness in their life is but an imagination, as an optimal life includes both blessings and crosses. Nature has provided many examples, which when measured quantity or quality wise, are in the second quartile, that is neither the best nor the worst.

Primary Data Analysis

Now, based on attached rank weights and row wise summations, overall rankings of the four factors by the 31 college professors are provided in Table 1.

their male counterparts, as exhibited in individual Spearman coefficients, not mentioned in the table. Thus male and female scholars get influenced in entirely different and independent ways by the four factors of power and influence. They are not alike in seeing the influence of those factors upon humankind, with most divergence being in Misinformation and Disinformation and Global Corporatism. As their personal, career and social preferences are nearly inverted in this feminised social and work environment, such a discordance of ranking has occurred.

II. CONCLUSION

This country, which once was of serenity and peace, and that lived in its rural micro and small industries and vocations, has been transformed into an intermediate socioeconomic system of inordinate extravaganza on one side and stinging impoverishment on the other. It is degenerating into a dumping yard and testing ground for the worldwide elites. The mass of rural workers, mostly farmers, craftsmen and artisans, are uprooted from their traditional sources of livelihood. They find no alternative but take recourse in virtual bonded labour. The transfer of population from both the agricultural and non-agricultural traditional ventures to industrial sector, together with the weakening of middle India, both socially and economically, has lead to the creation of a landless proletariat class for the first time in Indian history. Unwarranted migration to cities bring untold miseries to this once proud workmen and work women who fall upon the truth that custom is replaced by contract, cooperation by competition, intimate neighbourhood by impersonal anonymity, mutual help by exploitation, and the security of joint family by seclusive insecurity and underemployment. The breakneck pressure

on land, water and natural resources now makes agriculture, farming and allied activities as uneconomic and undignified lines. Unfortunately, all this happen dreadfully under the aegis of the State with new laws and regulations.

Fortunately in our times the balance is being achieved as the beast is tasting its demise at the hands of forces of balance that now shape the multiplex world order. It is being done on back of the military might of Russia, imperious economic rise of China, perseverance of Persia, market strength of Brazil and India, and the worldwide awareness of the deceit of the beast of Protestantism and Zionism. The approaching cataclysm of apocalyptic proportions, that coming out of Damascus, will bring back the humanity to sanity.
